## epic Standard Plan

1. The epic Standard pay monthly tariff plan ('Tariff Plan') is offered by Epic Communications Limited ('we') to its new and existing customers ('you') under these terms and conditions ('Specific Terms and Conditions'). When you subscribe to this Plan, you are automatically accepting to adhere to these Specific Terms and Conditions, [Mobile General Terms and Conditions](#) and any other relevant terms and conditions which will constitute a legally binding agreement between you and us (the 'Agreement').
2. You may subscribe to the Tariff Plan as from the 17th November 2020. This version of the Specific Terms and Conditions is applicable as from 18<sup>th</sup> May 2021.

### 3. Tariff Plan & Monthly Bundle

- 3.1 This Tariff Plan is available with a month to month rolling Agreement that recurs automatically every calendar month and which provides you with the monthly benefits listed in Table 1 below (the 'Monthly Bundle').
- 3.2 Upon subscribing to the Tariff Plan you will benefit from the Monthly Bundle that includes:

- 3.3 Any unutilised benefits from the Monthly Bundle shall not be carried forward and will be forfeited at the end of the month.
  - 3.4 Any usage beyond what is provided in the Monthly Bundle shall be charged at the rates set out in term 5 below. Any activity made towards local premium-rated numbers or other services will not be consumed from the Monthly Bundle and will be charged separately as per the rates as set out in term 5 below.
  - 3.5 For the first month of the Agreement, the Monthly Bundle will be allocated in full. This means that you will pay a proportion of your Monthly Access Fee which will be calculated on the number of days between your Tariff Plan activation date and the date of the first billing cycle. However, you will still receive the full benefits included in the Monthly Bundle.
  - 3.6 Mobile data speeds may vary from time to time due to contention ratios on the network and other factors outside our control, which include dependency on the network coverage as well as on your device. Currently our mobile data service on this Tariff Plan is able to support download speeds up to 270Mbps and upload speeds up to 20Mbps. - ### 4. Promotional Offer
- 4.1 Customers redeeming their 'Free internet for Students' Voucher Scheme' (during its respective validity) on any Epic fixed internet or internet on the move solution, will be eligible for a special promo offer ('Promo

Offer') when customer is either joining Epic or migrating from an Epic prepaid plan onto an Epic Standard 24-month agreement. For the avoidance of any doubt, the Promo Offer must be taken at the same time as when the 'Free internet for Students' Voucher Scheme' is redeemed from any Epic outlet and both offers can be taken up in conjunction with one another.

Customers can benefit from the below Promo Offer(s):

- 4.1.1 A reduced monthly access fee on epic Standard two year agreement, which shall be discounted to nineteen euro and ninety nine cents (€19.99) for a period of twenty four (24) months ('Discounted Period') and applicable when entering into a 24 month agreement. Upon the lapse of the Discounted Period, the full Monthly Access Fee above shall apply in its entirety and without any discount.

  - 4.1.2 A discount of €60 on any device in stock at any Epic outlet, to be redeemed when the customer is taking the device with Epic device monthly payment scheme.
- 4.2 Promotional Period: Offer is available between the 18<sup>th</sup> May 2021 and the 30<sup>th</sup> June 2021 (unless extended further) and until stock lasts. For the avoidance of any doubt the ['Promo Terms & Conditions'](#) shall apply.

## 5. Monthly Access Fee

- 5.1 All rates and charges quoted below are inclusive of VAT but are exclusive of excise tax or any other taxes which may be applicable.
- 5.2 You may benefit from the Tariff Plan at the price of thirty-four Euro & ninety-nine cents (**€34.99**) per month (the 'Monthly Access Fee') when choosing Direct Debit Mandate ('DDM') as your method of payment. If you do not choose DDM as your method of payment, an administrative fee of one Euro and fifty cents (**€1.50**) will be charged and shall be added to your Monthly Access Fee.
- 5.3 Should you choose to benefit from this Tariff Plan together with any one of our bundled services you will get additional discounts in accordance with the Bundled Services Terms and Conditions.
- 5.4 In the event that you wish to add a device to this Tariff Plan you may opt to benefit from the Device Monthly Payment Scheme. From Tier 0 to Tier 3 are available with this Tariff Plan (please refer to the Device Monthly Payment Scheme Terms and Conditions).

## 6. Rates outside Monthly Bundle and Information on Charges

- 6.1 The rates and charges provided in this term shall apply to any usage which goes beyond what is provided in the Monthly Bundle, i.e. once you use up your monthly benefits included in Monthly Bundle, or if you use services that are not included therein.

### 6.3 Rates for international usage

6.3.1 The charges listed below shall apply to any international usage (from Malta or from the EU/UK/UK) beyond any allowance included in your Monthly Bundle (if applicable). The following activity shall be charged as indicated in table below:

- a. Whilst in Malta: Calls/Videocalls/SMS/MMS from Malta to numbers Zone 1, 2, 3 and 4 countries;
- b. Whilst in the EU/UK: Any Calls/Videocalls/SMS/MMS from EU/UK to Zone 2, 3 and 4 shall be charged as indicated below.

When roaming in Rest of World countries, the Rest of World Traveller together with the respective terms and conditions shall [apply](#). This is the default tariff when roaming in Rest of World countries on this Tariff Plan. You may not opt out from the Rest of World Traveller tariff plan.

## 9. Termination and Migration

9.1 You can terminate your Agreement or migrate to a different tariff plan by providing us with a 30-day written notice without incurring any termination fees. In the event that you are migrating to a lower tariff plan with a lower Monthly Access Fee before the 30-day notice are over the charges mentioned in term 7 above shall apply. For the avoidance of any doubt these do not apply in case you are migrating to a higher tariff plan with a higher Monthly Access Fee or in case you are migrating after the 30-day notice are over. For the avoidance of any doubt, in the case of migration from any of our 2 year or 1 year agreements to this Tariff Plan, you need to terminate your agreement and pay the respective termination charge.

9.2 In case you are benefiting from other services together with this Tariff Plan the applicable fees in accordance the relevant terms and conditions shall apply.
