

When you subscribe to this Add-on, you are automatically accepting to adhere to these Specific Terms and Conditions, https://www.epic.com.mt/wp-content/uploads/2022/09/Mobile-General-Terms-and-Conditions.pdf, and any other relevant terms and conditions which will constitute a legally binding agreement between you and us (the 'Agreement').
- 2. You may subscribe to this Add-on as from the 26th May 2023. This version of the Specific Terms and Conditions is applicable as from 26th May 2023.

- 3.1. Promotion: The Add-on is being offered free of charge for the first 3 months of the subscription to the Add-on.
- 3.2. All rates and charges quoted above are inclusive of VAT but exclusive of any other taxes, which may be applicable.
- 3.3. The Add-on will be activated on the date that you subscribe to the Add-on and accept these Specific Terms and Conditions.
- 3.4. Any recurring charges (such as Monthly Add-on Fee) will be charged in arrears.
- 3.5. The Add-on is charged in full for the month. For the avoidance of doubt, addition of the Addon during the month, will have the monthly access fee invoiced in full at the beginning of the following month.

4. The Monthly Add-on:

- 4.1. The Add-on is available with a month-to-month rolling Agreement that recurs automatically every calendar month.
- 4.2. The Add-on carries the following features:

4.2.1. Malicious App Protection

Protects your Android device from both known and unknown malicious apps and updates. Protects your iOS device from apps not from the App Store.

4.2.2. OS Protection

Detects suspicious device behaviour and alerts you if someone has gained control over your operating system.

4.2.3. Advance Phishing Protection

Blocks phishing attacks both from known and unknown phishing-sites and apps.

4.2.4. Safe Browsing

Protects against malicious websites on all browsers, so you can surf safely.

4.2.5.Anti Bot

Blocks bots from communicating with your device and sending data to outside Command & Control servers, keeping your data safe from being accessed by hackers.

4.2.6.USB and Bluetooth Protection

Protects against malicious apps when you are connected to USB and Bluetooth.

4.2.7. Privacy Guard

Views apps' permissions and controls which apps can see and access your device camera, microphone, location, contacts, and other personal data.

4.2.8. WiFi Network Security

Protects your data from being caught in Man-in-the-Middle attacks when connected to Wi-Fi, so your data remains safe from prying eyes.

4.2.9. Content Filtering

Actively filters all URLs, according to your specified definitions, protecting you from inappropriate content.

4.2.10. Security Incident Report

Notifies you of any on-device security incidents based on your pre-defined customization/Pre-specified definitions.

5. Activating and Installing the Add-on

- 5.1. You may request to add this Add-on by visiting any epic store or calling us on 247.
- 5.2. The installation is carried out by downloading the Epic Malta Mobile Security app ('App') through the link which shall be provided in the message (SMS) that you will receive after your request of the Add-on. Detailed instructions are available on this <u>link</u>.
- 5.3. The delivery of the service is made by activating the App. The activation of the App is dependent on your action to download the App after receiving the SMS with the link to the App. Such SMS may take up to twenty-four hours from your request to add the Add-on.
- 5.4. The App can only be activated on one device at a time.
- 5.5. If you change your phone, you will not be unsubscribed from the service. Simply install the Security App on your new device and follow the steps above in term 5.2 and 5.3. Once done, Add-on will be activated on the new device and deactivated from the old device within 24 hours. This also applies if you uninstall and App by mistake.

6. The App

6.1. The Add-on is provided by Epic in collaboration with CheckPoint (the 'Manufacturer'). The copyright of the App belongs to the Manufacturer. The Subscriber must accept the use terms as described in the "Terms of Use" for the installation of the App, as well as accept the privacy policy of the Manufacturer which is visible once you open the App for the first time.

6.2. We do not warrant the correctness, accuracy, reliability, or other relevant property of the App and does not provide any warranty as to its marketability, suitability for the specific purpose and use, or to the security against third party attacks or force majeure events of the services which are subject to terms and conditions.

- 6.3. We shall assume no responsibility for the App and/or for any malfunction, faults, viruses, reduced performance, discontinuation or any form of degradation of the Add-on. Epic shall not assume any responsibility for acts or omissions of third parties and other causes which are beyond its control. We are not liable for any damage or defects caused to you by the installation and use of the Add-on.

7. Privacy

7.1. In order to activate the App and for your device to be protected, monitoring of your internet traffic through the App is required when you are navigating through the mobile network or via WiFi network. You hereby declare that you have been informed and consent to the specific processing of your traffic data, which is absolutely necessary for the provision of the Add-on and only for the specific purpose in accordance with the privacy policy of the Manufacturer as available at the link <u>here</u>.

8. Termination and Migration

- 8.1. The Add-on is offered on a month-to-month basis and no penalties are applicable for early termination. Hence for the avoidance of doubt, you may terminate the Add-on at any point in time.
