These terms and conditions form an integral part of your agreement for the provision of the services and shall be read in conjunction with the Specific Terms and Conditions of the selected service tariff plan you are subscribing to ('Tariff Plan'), the Device Monthly Payment Scheme Terms and Conditions available at [Pay Monthly – Consumer – Tariff Plans & Services](#), General Mobile Terms and Conditions available at [Mobile-General-Terms-and-Conditions.pdf \(epic.com.mt\)](#) and Promo General Terms and Conditions available at [Promo-General-Terms-and-Conditions.pdf \(epic.com.mt\)](#). These terms are applicable as from 16<sup>th</sup> May 2023 until 30<sup>th</sup> June 2023.

## 2. **The Switch to Epic Offer** ('Offer'):
