Epic International Student Plan

1. The Epic International Student Plan (the 'Plan') is a prepaid plan and the Student Bundle (the 'Bundle') is a prepaid recurring bundle offered by Epic Communications Limited ('we') to its new prepaid customers ('you') under these terms and conditions ('Specific Terms and Conditions'). When you subscribe to this Plan, you are automatically accepting to adhere to these Specific Terms and Conditions, [Mobile General Terms and Conditions](#) and any other relevant terms and conditions which will constitute a legally binding agreement between you and us.
2. Upon purchasing the Bundle, you will be automatically subscribed to the Plan and lose any unused benefits that you were benefitting from your previous plan/bundle. For the avoidance of any doubt, once subscribed to this Plan your usage will be charged in accordance with these Specific Terms and Conditions.
3. You may benefit from the Plan and Bundle as from the 28th April 2025. This version of the Specific Terms and Conditions is applicable as from 28th April 2025.

4. The Student Bundle Benefits

- 4.1. The prices and rates specified below are inclusive of Value Added Tax and of the excise tax which is being deducted from the topped-up amount. For the avoidance of any doubt any other taxes which may be applicable shall be deducted accordingly.

4.1.1 **Introductory Offer (Welcome Offer):** We are offering a discount (Welcome Bundle) to any customer purchasing the Epic International Student Plan for the first time between the 28th of April 2025 until the 28th of February 2026 ("Promotional Period") unless extended further by us. Once the customer sends the exclusive code, he/she will benefit from the Welcome Bundle with the same benefits as Student Bundle however it's free for seven (7) days (Offer Period) instead of €4.49 for fourteen (14) days (the Student Bundle's standard price) for the first purchase. Once the Offer Period ends, or if all allowances are used before the end of the Offer Period, the customer may purchase the Student Bundle for 14 days at a cost of €4.49. Refer to Table 4 below for detailed instructions on how to purchase the Student Bundle. Once the Student Bundle is purchased, it will automatically renew as long as there is sufficient credit available.

4.2. You can benefit from the Bundle upon successfully purchasing it through the credit in your account or else through your bank card. By purchasing the Bundle, you are opting for a recurring automatic purchase (of the same Bundle).

4.3. The minutes & SMS benefits provided can be used to call or text any Maltese mobile or fixed number whilst in Malta and whilst roaming in EU, and to any EU fixed and mobile numbers whilst in EU. These does not apply for calls or text done from Malta towards EU numbers, referred to as international minutes or SMS, refer to term 7 for more information on such rates. Calls and SMS shall be deducted from the corresponding minutes included in the plan.

Set-up charge: For International calls to Zone 2 and 3, a set up charge of €0.75c per call will be applied. Rates are charged on a per minute basis.

8. How to benefit/stop benefiting from the Plan and Bundle:

- 8.1. You can purchase/re-purchase the Bundle by using one of the below methods:

By logging in to Epic Account using [Epic App](#).

OR

by logging in to Epic Account using Epic Web

OR

by sending a SMS to 16200 from the Mobile number you wish to subscribe – refer to Table 4 below

OR

by visiting one of our retail [stores](#) with your valid identification document

- 8.2. Upon purchasing the Plan, we shall send you a verification SMS confirming that your order was successful and that you will be automatically switched on the Plan upon such confirmation. Following this confirmation SMS, you shall receive a second confirmation SMS confirming the successful purchase of the Bundle. In the event that you use

your mobile handset before receiving the second SMS notification, you shall be charged according to the plan you were subscribed to prior to the purchase of the Bundle.

8.3. The following are the SMS codes to purchase or stop the repurchase of the Bundle. You may purchase/stop purchasing any Bundle at any time without incurring any penalty.

8.4. Should you stop the repurchase of the Bundle, you will nonetheless benefit from the active Bundle until the end of the Bundle Validity Period. For the avoidance of doubt, in case you stop the repurchase of the Bundle you will remain subscribed to the Plan and the rates listed in Table 2 in the Out of Bundle 1 column shall apply.

8.5. Upon expiry of the Bundle Validity Period, you shall automatically be charged for the price of the same Bundle (as indicated in Table 1), and the Bundle shall be re-activated for another 14 days. You will be notified via an SMS to this effect. Any unused SMS, minutes and data will be forfeited.

8.6. If, upon the expiration of the Bundle Validity Period, you would not have sufficient credit (less than the price of the specific Bundle) remaining in your account or your bank card purchase fails, you will be notified via SMS. In this case, any remaining benefits shall be forfeited and you will be placed on the Plan and the out of bundle rates in Table 2 in the Out of Bundle 2 column above shall apply. Upon the expiration of the Bundle Validity Period, we will keep retrying to repurchase the Bundle for 28 days ('Retrying Period'). Upon topping-up your account or enabling the bank card purchase during the Retrying Period, the Bundle shall be re-purchased and the price of the Bundle (as indicated in Table 1) shall automatically be deducted. Once this amount has automatically been deducted, you shall be notified by SMS. In the case that you wish to benefit from the Bundle after the Retrying Period expires, you must re-purchase it in accordance with Term 8.1.

8.7. You can benefit from different Bundles simultaneously; however, the following shall apply:

8.7.1. If during the Bundle Validity Period, you purchase another Bundle (of the same value) its Validity Period shall commence on the date of the subsequent purchase. Any unused SMS, minutes & data will be forfeited.

8.8. You can monitor your usage by dialling *123# on your phone. You will first receive an on-screen notification displaying your remaining credit balance. Shortly after, you will receive an SMS containing a detailed summary of your remaining allowances. You are hereby being advised that this only serves as guidance as it may not always be accurate. Therefore, should you exceed the benefits provided with your Bundle; you will still be liable for all charges for out of bundle usage.

8.9. The SIM Card provided under this agreement is subject to a maximum usage period of six (6) months from the date of activation. Upon the expiration of this period, the SIM Card will be permanently deactivated, regardless of its usage status or remaining activity. No further services shall be available through the SIM Card following deactivation. If you require another SIM Card after these 6 months, kindly visit one of our Epic [stores](#) for assistance.

8.10. Epic reserves the right to verify, at its sole discretion, that any customer subscribed to this prepaid Plan is in Malta and is actively enrolled as a student at a language school in Malta. Eligibility for this Plan ends once the school enrolment period has ended and/or customer is no longer staying in Malta. Epic shall carry out random checks to confirm eligibility. In case you fail to provide us with sufficient proof of enrolment and evidence that the Plan is being

used in Malta, when requested, we reserve the right to refuse any such subscription request or to migrate you from this Plan to the Base Plan pre-paid tariff plan available at the time. You shall receive prior notification stating that you have been migrated off this Plan.
