



Fixed SOHO Offers Terms and Conditions

1. These terms and conditions form an integral part of your agreement for the provision of the services and shall be read in conjunction with the Specific Terms and Conditions of the selected service tariff plan you are subscribing to ('Tariff Plan'), General Fixed Terms and Conditions available at [General Fibre Terms & Conditions | epic](#) and Promo Terms and Conditions available at [Promotions – Competitions & Other | epic](#). These terms are applicable as from 1st July 2026 until 24th August 2026 or while offer stock lasts ('Offer Period').
2. **The Fixed SOHO Offers ('Offer'):**
