



Mobile SOHO Offers Terms and Conditions

1. These terms and conditions form an integral part of your agreement for the provision of the services and shall be read in conjunction with the Specific Terms and Conditions of the selected service tariff plan you are subscribing to ('Tariff Plan'), General Mobile Terms and Conditions available at <https://www.epic.com.mt/general-mobile-terms-conditions/>, the Device Monthly Payment Scheme Terms and Conditions available at <https://www.epic.com.mt/tc-pay-monthly-consumer-tariff-plans-and-services/> and Promo Terms and Conditions available at [Promotions – Competitions & Other | epic](#). These terms are applicable as from 1st July 2026 until 24th August 2026 or until stock offer lasts ('Offer Period').

2. The Mobile SOHO Offers ('Offer'):
